## Park Rules and Ordinances

Adopted March 21, 2011  
Amended August 20, 2012  
Amended December 12, 2022

### **General Park Rules**

- Park hours: 6:00 a.m. – 10:00 p.m. except for camping and/or fishing
- No camping or parking behind any of the District Office Buildings
- Riding of ATV's and golf carts is prohibited with the exception of Peace Officers or District personnel in the discharge of their duties
- All state laws regulating operation, registration, and insuring of vehicles, campers, RV's, etc. apply to park
- District is not responsible for lost or stolen items
- Glass containers are prohibited
- Possession of alcoholic beverages is strictly prohibited
- Dogs will be leashed unless under immediate supervision
- No disturbing of the peace, i.e. loud music, loud noise, etc. in park or campsite
- Vehicles on lakebed are prohibited
- No driving off designated roadways
- District reserves the right to amend park rules without notice and deny access to park facilities at any time
- Violations to any of the above District rules, Ordinances, Federal, State, and local laws will result in appropriate penalties
- No swimming is allowed after dark

### **Camping**

- No fee for camping
- Campsites are permitted on a first-come, first-serve basis
- Police Officer will issue Permit to a responsible person for the campsite
- Campsite must display permit card in plain view from nearest road
- 7-day limit in park (Not to exceed 7 days in a 30 day period)
- Campsite is to be kept clean and litter free (Extra trash bags may be obtained from the Police Officers)
- No limit on number of guests the permitted camp may have, as long as their host will ensure that the guests follow the park rules
- Campers who violate Park Rules, Ordinances, Federal, State, and local laws may be required to leave the park by order of any Texas Peace Officer
- Tents without permits and other abandoned items left in park may be removed by the District
- All Rules, Ordinances, Federal, State, and local laws must be abided by to retain current and future camping privileges at the District Park
- In order to be issued a camping permit, one individual must be at least 21 years of age and possess a valid DL and a vehicle for transportation
- In order to be issued a camping permit, a tent, camper, RV or a vehicle that has been modified to accommodate camping, is required

### **Campfires and Fireworks**

- Fireworks are prohibited on District Property
- Fires on lakebed are prohibited
- Rocks will not be removed from shoreline for campfires or other purposes
- Extinguish campfires prior to leaving
- No fires during county wide burning ban
